HON. WILLIAM C. ANDREWS, III (Ret.)

Retired judge, 8th Judicial Circuit in Hampton, Judge Andrews graduated from Hampden-Sydney College and the College of William and Mary, Marshall-Wythe School of Law, J.D. in 1973. He was engaged in the general practice of law from 1973-1990, most recently as a principal in the firm of James, Richardson, Andrews, and Griffin. Judge Andrews served in the U.S. Navy. He served as a substitute judge 1981-1990, General District Judge, 1990-1996, and Circuit Judge 1996-2007. He is a member of the Virginia State Bar, the Virginia Bar Association, and the Hampton Bar Association.
